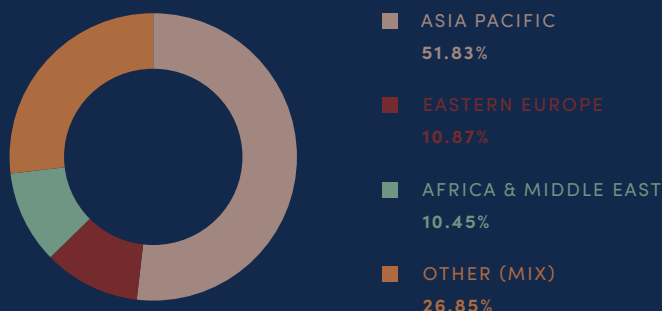

## Strategy overview

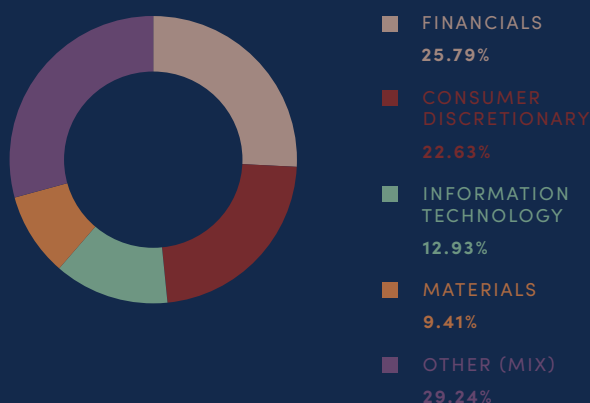
